### DIRECTOR'S ORDER

**Re: Director's Order Rescinding Various Orders**

I, Stephanie McCloud, Director of the Ohio Department of Health (ODH), pursuant to the authority granted to me in R.C. 3701.13 to "make special orders...for preventing the spread of contagious or infectious diseases" Order the following:

1. The Director's Order to Limit Access to Ohio's Jails and Detention Facilities signed March 15, 2020 is rescinded.
2. The Director's Order to Release Protected Health Information to Ohio's First Responders signed April 14, 2020 is rescinded.
3. The Director's Order Requiring the Use of Facial Coverings in Child Education Settings signed August 13, 2020 is rescinded.
4. The Director's Order for Retail and Business Compliance for Facial Coverings throughout the State of Ohio signed December 23, 2020 is rescinded.
5. The Second Amended Director's Order on Adult Day Support Services and Vocational Habilitation Services signed March 17, 2021 is rescinded.
6. The Third Amended Director's Order on the Opening of Senior Centers signed May 4, 2021 is rescinded.
7. The Third Amended Director's Order on the Opening of Older Adult Day Services Centers signed May 4, 2021 is rescinded.
8. This Order shall be effective at 12:01 a.m. on June 2, 2021.
